Western Gas Resources Inc ('Western Gas') is managing the development of 8 wells in one Section at the Company's Esponda Project in the Powder River Basin. The Company reimburses Western Gas for its 25% working interest in this Section. During the March 2005 quarter, the Company paid \$46,000 (US\$35,000) to Western Gas out of a total expenditure by Western Gas of \$184,000 (US\$140,000).

Kennedy Oil is managing the development of, and sole funding, 12 wells at the Company's Esponda Project in the Powder River Basin to earn a working interest of approximately 60% of each well. These wells form part of a larger development program by Kennedy Oil. Total development expenditure to 31 December 2004 totalling \$2,685,802 (US\$2,093,852) was incurred by Kennedy Oil to bring these 12 wells to a production stage. Revenue from the sale of gas produced from the 12 wells, which will commence in conjunction with the larger Kennedy Oil development program, will first be used to repay Kennedy Oil's development and operating costs.

Well development by both Western Gas and Kennedy Oil are completed. These wells are being dewatered and the commencement of gas production is being managed by the operators in conjunction with their larger development programs.
